



# College of St Hild and St Bede

## College Fees and Charges 2018/19

### 1. SRC Membership (£50 per year x No. of course years; payable in 1<sup>st</sup> year only)

The Student Representative Council (SRC) Levy is excellent value for money, providing benefits to SRC members over and above those available to non-member students of the College. The benefits of membership include:

- The support of a full time President (paid member of staff) who works for the SRC; helps to facilitate all student based activities and events; and represents the student body at College and University level
- Access to SRC levels of welfare
- Access to the SRC Executive Committee (the Exec; please see Freshers' Handbook for further information about what the Exec do)
- Ticket preference at SRC run events; including the summer and winter balls (non-members cannot access early-bird deals and may be required to pay a premium on the members' price)
- The ability to join an SRC club or society with member subscription where non-member subscription is of greater price
- The ability to join the SRC run College gym
- Access to student discounts organised by the Common Room (non-members cannot access such discounts)
- Voting rights in all SRC elections (Exec and Non-Exec roles)
- Voting rights within the SRC for all matters relating to the running of the SRC (non-members cannot vote)
- The right to run for positions of responsibility within the SRC including the Executive Committee and representative roles

The vast majority of students join the SRC and non-members will be subject to paying a premium for some activities; the extent of the premium is specific to the particular activity and will be publicised appropriately.

### 2. Academic Gown Hire (£5; for matriculation; payable in first year only)

At Hild Bede we wear academic gowns only for matriculation and for graduation. The matriculations (University and College) are an important part of your induction into the University and College and together they formally mark the start of your time here as a student. Matriculation without a gown is permissible but the vast majority of Hild Bede students wear gowns.

### 3. Hild Bede Alumni Association Membership (£30; payable in 1<sup>st</sup> year only)

The Hild Bede Alumni Association (the Association) is the association for alumni of the College of St Hild and St Bede and its parent colleges (the College of the Venerable Bede and St Hild's College) and has a membership of many thousands of former students from around the world. All new students of the

College are invited to become members of the Association. The membership fee is for lifetime membership of the Association, and is paid only once.

Members of the Association are also, by the payment of an additional fee (currently £15), able to take out Premier Membership of the Association. This will entitle them to a reduction on the cost of attending Association events both in Durham and elsewhere.

The Association exists to enable alumni to maintain links with the College(s) and with each other; to support the academic and social development of the current students of the College; and to encourage events in pursuance of the above.

The rights and benefits of membership of the Association include:

- Receipt of electronic versions of the Association's annual publications (hard copy is available for a small additional annual fee);
- Voting rights at Association meetings and elections;
- Eligibility to run for Association positions;
- Access to events organised by the Association both in Durham and elsewhere.
