

## Community Transformation (TMM3471)

**Aims:** This module involves a small group of students being 'apprenticed' for the duration of this module to a practitioner in community organising, community development or social enterprise. Some of that time will be spent experiencing first hand the creative and organisational challenges the supervisor faces in his or her own context. The supervisor will also mentor the group as they develop a proposal for action in a context known to the students, which may be the area in which the TEI is located, or the context of a placement undertaken alongside another module.

This module aims:

To give students a theological framework for Christian mission focused on the Kingdom of God in local contexts.

To introduce students to the disciplines of either community organising, community development, or social enterprise along with their attendant methodologies and practices.

To enable students to engage with a real practitioner in one of these disciplines in order to learn from their experience and expertise and be guided in developing their own practice.

To develop critical and theological reflection on the practice of either community organising, community development or social enterprise.

To give students an awareness of the organisational, legal and financial challenges associated with the practice of one of these disciplines in a real context.

Each TEI will select which of the disciplines it will focus on with any given cohort, depending on its own areas of expertise, the availability of supervision for a small group of students and students' own aspirations.

Content:	<p>A survey of biblical and theological traditions concerned with the Kingdom of God, which could include themes such as justice, peace and human flourishing.</p> <p>An overview of the development and methodological foundations of either community organising, community development or social enterprise, and their practice in contemporary contexts.</p> <p>A critical evaluation of the interrelation of the above methodology and practice in the light of biblical and theological commitments.</p> <p>A small group placement in a context where community organising, community development, or social enterprise is being practiced.</p>
