The CCS at Durham University invites applications from full-time and part-time candidates (both existing students and new candidates) for fixed-term Postgraduate scholarships and bursaries in Catholic Theology / Catholic Studies as listed below.

**Please note:** All applicants must be able to commit to regular in-person participation in the academic programme of the CCS during the period of any award. [See note (f) below.]

An application form may be obtained from the CCS Manager, [theresa.phillips@durham.ac.uk](mailto:theresa.phillips@durham.ac.uk), or downloaded at [CCS-Scholarships-Bursaries-Application-Form-2025-26-Apr-25.docx](#) and must be returned to the CCS Manager **by the deadline** given below.

Before submitting an application, applicants who are new candidates for a postgraduate degree within the Department of Theology and Religion must complete a standard DU application for postgraduate admission on-line (citing 'CCS Scholarship' in the Field of Study area and in the Finance/funding section). Applicants must have been formally offered a place on an eligible course of study before their application for a CCS Scholarship/Bursary can be considered. The advised deadlines for completing the online programme application with all supporting documents are given below. (For details on how to apply see [Application Process - Durham University](#))

<sup>2</sup> Applications from students on the DThM programme are only invited **after** the first taught phase of the programme.

<sup>3</sup> First year IPhD students who satisfy the eligibility criteria for the MA in Theology and Religion may apply (see note (b) below). Other students are only eligible to apply after the taught MA phase.

<sup>4</sup> In exceptional circumstances, a PhD candidate's primary supervisor may be located in another academic department at Durham University other than the Department of Theology and Religion. However, at Masters level (including the first year of any proposed I-PhD) candidates must be pursuing the MA in Theology and Religion (V8K407) within the Department of Theology and Religion and meet the requirements under note (b) to be eligible to apply.

## **AWARDS AVAILABLE FOR 2025-26**

### **THE SISTERS OF CHRISTIAN EDUCATION LOUIS LAFOSSE PhD SCHOLARSHIP FUND**

(three-year full-time (six years part-time) award, subject to satisfactory academic progress)

In association with the Sisters of Christian Education up to TWO full fee (UK/Home level) PhD scholarships, both with a maintenance allowance, are to be awarded on a competitive basis to PhD candidates (in receipt of a formal offer) in Catholic Theology / Catholic Studies within the Department of Theology and Religion at Durham University.

Applications are invited from full-time and part-time candidates who are able to share regularly in person in the academic programme of the CCS. Fees will be met in full at the UK/Home rate and an annual maintenance allowance at the UKRI's national rate (pro rata) will be made.

In all cases, alongside academic excellence and potential, consideration will also be given to personal financial circumstances.

Normally only applications from new students will be considered for the Louis Lafosse Scholarships. Only in cases of particular excellence and financial need will applications from current students be considered.

### **THE JANET ERSKINE STUART SCHOLARSHIP FUND**

(one year award, renewable)

In association with the Society of the Sacred Heart (RSCJ) donated funds from an endowment may be awarded on a competitive basis to full-time or part-time postgraduate candidates (both existing students and new candidates in receipt of formal offers) in Catholic Theology / Catholic Studies within the Department of Theology and Religion.

Applications are invited from students on programmes in Durham who are able to share regularly in-person in the academic programme of the CCS, and from students on the Distance Learning Programmes in Catholic Theology.

These funds may be awarded as full or partial support towards Home/UK level tuition fees.

The fund is intended primarily to support teachers or chaplains, and particular consideration will be given to applications from teachers and chaplains in the UK. Applications are especially invited from:

- Teachers of RE wishing to pursue an MA to enhance the quality of their subject knowledge.
- Teachers of any discipline who wish to retrain to teach RE.

Alongside academic excellence and potential, consideration will also be given to personal financial need.

### **THE MARY WARD POSTGRADUATE SCHOLARSHIP FUND**

(one-year award, renewable)

In association with the Congregation of Jesus (<http://www.congregationofjesus.org.uk/>) donated funds up to a total of £25,000 may be awarded on a competitive basis to full-time or part-time postgraduate candidates (both existing students and new candidates in receipt of formal offers) in Catholic Theology / Catholic Studies within the Department of Theology and Religion and who are able to share regularly in the academic programme of the CCS. These funds may be awarded as a combination of one or more fixed-term Postgraduate Scholarships (full-fees) and/or one or more fixed-term Postgraduate Bursaries (partial help towards fees). The total amount of £25,000 need not be awarded in a given year and may be split between candidates.

Alongside academic excellence and potential, consideration will also be given to personal financial need.

### **THE CATHERINE MULLIGAN SCHOLARSHIP FUND**

(one-year award, renewable)

In association with Mater Ecclesiae donated funds up to a total of £13,500 may be awarded on a competitive basis to full-time or part-time postgraduate candidates (both existing students and new candidates) within the Department of Theology and Religion, and who are able to share regularly in person in the academic programme of the CCS. These funds may be awarded as full or partial support towards tuition fees. The total amount need not be awarded in a given year and may be split between candidates.

Alongside academic excellence and potential, consideration will also be given to personal financial circumstances.

### **THE ST JUDE POSTGRADUATE SCHOLARSHIP FUND**

(one-year award, renewable)

In association with an individual benefactor who has received many graces and favours through the intercession of St Jude, donated funds up to a total of £8,000 may be awarded on a competitive basis to full-time or part-time postgraduate candidates in Catholic Theology / Catholic Studies within the Department of Theology and Religion (both existing students and new candidates in receipt of formal offers) and who are able to share regularly in-person in the academic programme of the CCS. These funds may be awarded as a combination of one or more fixed-term Postgraduate Scholarships (full fees) and/or one or more fixed-term Postgraduate Bursaries (partial help towards fees). The total amount of £8,000 need not be awarded in a given year and may be split between candidates.

Alongside academic excellence and potential, consideration will also be given to personal financial need.

### **THE EDITH STEIN POSTGRADUATE BURSARY FUND**

(one-year award, renewable)

In association with the Carmelite Nuns (<https://carmelitenuns.uk>) donated funds up to a total of £7,500 may be awarded on a competitive basis to full-time or part-time postgraduate candidates (both existing students and new candidates in receipt of formal offers) in Catholic Theology / Catholic Studies within the Department of Theology and Religion and who are able to share regularly in-person in the academic programme of the CCS, or to students on the Distance Learning Programmes in Catholic Theology. These funds may be awarded as full or partial support towards tuition fees. The total amount of £7,500 need not be awarded in a given year and may be split between candidates.

Alongside academic excellence and potential, consideration will also be given to personal financial need.

### **THE SIR RICHARD ABBEBURY POSTGRADUATE SCHOLARSHIP FUND**

(one-year award, renewable)

The Sir Richard Abberbury Scholarships are funded by [the Hartley Trust](#). Donated funds up to a total of £5,000 may be awarded on a competitive basis to full-time or part-time postgraduate candidates in Catholic Theology / Catholic Studies within the Department of Theology and Religion (both existing students and new candidates in receipt of formal offers) and who are able to share regularly in-person in the academic programme of the CCS. These funds may be awarded as a combination of one or more fixed-term Postgraduate Scholarships (full fees) and/or one or more fixed-term Postgraduate Bursaries (partial help towards fees). The total amount of £5,000 need not be awarded in a given year and may be split between candidates.

Alongside academic excellence and potential, consideration will also be given to personal financial need.

### **THE CENTRE FOR CATHOLIC STUDIES (CCS) SCHOLARSHIP FUND**

(one year award, renewable)

The CCS are grateful to an individual donor, who wishes to remain anonymous, for the provision of funds towards a CCS Scholarship Fund. Donated funds up to a total of £17,000 may be awarded on a competitive basis to full-time or part-time postgraduate candidates in Catholic Theology / Catholic Studies within the Department of Theology and Religion (both existing students and new candidates in receipt of formal offers) who are able to share regularly in-person in the academic programme of the CCS, or to students on the Distance Learning Programmes in Catholic Theology. These funds may be awarded as a combination of one or more fixed-term Postgraduate Scholarships (full fees) and/or one or more fixed-term Postgraduate Bursaries (partial help towards fees). The total amount of £17,000 need not be awarded in a given year and may be split between candidates.

Alongside academic excellence and potential, consideration will also be given to personal financial circumstances.

#### **DEADLINES**

Before applying for any of the above awards, new candidates for a postgraduate degree within the Department of Theology and Religion must complete a standard DU application for postgraduate admission with all supporting documents **by Sunday 11 May 2025**.

Closing date for applications for the above CCS Postgraduate Scholarships and Bursaries for 2025/26 is **Sunday 1 June 2025**.

More than one award may be made from each of the above funds in a given year.

Applicants may also be considered for other awards that become available.

In all cases, applicants are required to state their financial position and to update the [CCS Manager](#) of any changes to their financial situation after submitting their application and during the period of any award.

## NOTES ON CCS SCHOLARSHIPS

Before applying, applicants for CCS Postgraduate Scholarships and Bursaries must be aware of the following points:

- (a) To be eligible for consideration, the applicant will be registered in, or applying to, the Department of Theology and Religion<sup>5</sup> at Durham University, and the applicant's research topic will be in the area of Catholic Theology / Catholic Studies. The following areas of Catholic Theology / Catholic Studies will be considered:
- Constructive Catholic Theology;
  - Catholic Historical Theology;
  - Interpretation of Scripture in Catholic Tradition;
  - Catholic Social Thought and Practice;
  - The History of Catholicism;
  - Lived Catholicism;
  - Social-Scientific study of Catholicism;
  - Franciscan Studies.

If you are unsure whether your area of research would be considered, please do get in touch.

- (b) Note for applicants from the MA in Theology and Religion (V8K407): To be eligible for consideration applicants must opt to pursue an informal pathway in Catholic Studies by undertaking the following:

- Classic Texts in Christian Theology THEO 43430

And at least one of the following modules: (*DL denotes an online Distance Learning module*)

- Catholic Theology: A Preliminary Tour (DL) THEO 45930
- Catholic Social Thought and Practice (DL) THEO 46230
- The Theology of Thomas Aquinas Selected Topics (DL) THEO 46330
- Conceiving Change in Contemporary Catholicism (DL) THEO 46030
- Conceiving Change in Contemporary Catholicism THEO 40230
- Twentieth Century Catholic Theology (DL) THEO 46130
- High Medieval Franciscan Theology (DL) THEO 46530
- Faith and Reason (DL) THEO 46430

Applicants from the MA in Theology and Religion (V8K407) must also pursue a dissertation with a clear link to Catholic Theology / Catholic Studies as outlined in (a) above.

- (c) It is important that new candidates for postgraduate programmes in the Department of Theology and Religion complete their online programme application by the deadlines given above as CCS Scholarship/Bursary applicants must have been formally offered a place on an eligible programme of study before their application for a CCS Scholarship/Bursary can be considered.
- (d) Eligible current Department of Theology and Religion students who have not previously been in receipt of a CCS Scholarship or Bursary may apply for 2025-26. It is expected that these applicants will have regularly participated in CCS seminars and events during their registration in the Department of Theology and Religion.
- (e) All tuition fee only scholarships and bursaries will be awarded on the basis of demonstrated financial need, coupled with excellent academic performance.
- (f) Receipt of any CCS Scholarship or Bursary implies that recipients will share regularly in-person in the academic programme of the CCS through participation in such things as: the thrice-termly Catholic Theology Research Seminar (CTRS), the annual Bishop Dunn Memorial Lecture, the CCS Friends' and Benefactors' event, the Early Career and Postgraduate Conference, and other such events organised by the CCS for the CCS community. Where appropriate and where compatible with

students' other academic commitments, students may be asked to participate in the planning and delivery of such activities. **Note (f) does not apply to students on Distance Learning programmes.**

- (g) Following application and during the period of any award, receipt of any other scholarship, bursary, or financial assistance towards the cost of tuition fees and/or associated living costs must be declared to the CCS Manager and may lead to a reduction in (and in extreme circumstances total cancellation of) the level of the scholarship/bursary award. Failure to declare any such additional assistance will automatically carry the penalty of total cancellation of any CCS Scholarship/Bursary award.
- (h) With the exception of the Louis Lafosse Scholarships, due to the limited funding available, support cannot be given towards maintenance costs, just help towards tuition fees. PhD scholarships/bursaries: Priority will be given to applicants who are pursuing a research topic in the area of Catholic Theology / Catholic Studies, who demonstrate financial need, and who can demonstrate their ability to meet their own maintenance costs (with the exception of the Louis Lafosse Scholarships) and any shortfall in tuition fees.
- (i) With the exception of the Louis Lafosse Scholarships, awards are made for one full academic year and do not imply commitment to renewal for future years of study.
- (j) That said, priority will be given, where possible, to students who have already been in receipt of a CCS Scholarship or Bursary during the previous academic year and who have at least one further year of study to pursue. Further awards are subject both to sufficient funds being available and to a satisfactory progress report being received from the student's primary supervisor prior to the meeting of the CCS Scholarships Committee in June.
