Moral Injury: some provisional definitions

"Perpetrating, failing to prevent, or bearing witness to acts that transgress deeply held moral beliefs and expectations may be deleterious in the long term, emotionally, psychologically, behaviourally, spiritually, and socially" (Litz et al., 2009: 695).

"A betrayal of what's right, by someone who holds legitimate authority (e.g. in the military - a leader), in a high stakes situation. All three". (Shay, 2014: 183)

"Moral Trauma - the existential, psychological, emotional and or spiritual trauma arising from a conflict, violation or betrayal, either by omission or commission, of or within one's moral beliefs or code(s)" (Jamieson et al., 2020: 1060).

Definitional key moral themes

- Core: Transgression / betrayal: moral beliefs / expectations / values / codes
- No clear reference to ethical framework / origins of moral values
- No explicit reference to Moral Conscience

Return to Shay's Achilles

- Greek themes / eternal moral themes rooted in humanity.
- *Themis*: ideas of right based on Natural Justice: Betrayal.
- Aristotelian root: Natural Justice as building blocks of Western Ethical thinking
- Natural Law thinking / Just War thinking.
- Appeal possible to higher moral law: Antigone / Nuremburg Trials (crimes against humanity) / Martin L-K (Birmingham Jail letter).
- Develops into Positive Law: societal / international / IHL / Professional Codes.

Why a conceptual line?

- Moral Injury Construct still crystalizing: here's an under-explored basic element
- Natural Law thinking offers a metaphysical reference point: independent of specific culture / religions
- Moral building block: arises from human reason reflecting on Natural Justice
- Link offers theoretical objectivity / intelligibility / universality: aims
 of any moral theory
